To be eligible, Members must gain the endorsement of no fewer than 20 Members eligible to vote. Applicants must also be aged 18 years or older and have been a voting Member of the Club for at least 24 months prior to application.

The Club is committed to building a diverse workforce and this starts with the Board. The Board actively encourage nominations from Members from groups that are currently under-represented at the Club or more broadly across the sector. Applications from women, people with disabilities and people from ethic minority groups are encouraged in particular. In accordance with the Rules, all applications will be reviewed by the Board's Nominations Committee. Shortlisted applicants will be asked to attend an interview with the selection panel on the 26 or 27 March 2024. Shortlisted applicants may also be asked to consent to due diligence checks, provide references and to declare interests as part of the selection process.

Following the selection phase, the Nominations Committee will recommend up to two candidates to the Board for election by the members at the annual general meeting currently scheduled to take place on Saturday 27 April 2024.
