

Department Overview

The collaborative Yorkshire County Cricket Club Science and Medicine team aim to provide first class health and performance support to a wide range of players across the Professional, Academy and Pathway for both Men's and Women's squads. The medical department work closely with numerous stakeholders including coaches, backroom staff and the rest of the multi-disciplinary team aiming to provide the best service for improvement in player physical, mental health and wellbeing to maximise their full potential on the pitch.

Job Purpose

The purpose of this role is to provide medical support services to Yorkshire County Cricket Club's Senior Men's Players. This role will provide the highest standard of physiotherapy provision to our Men's professional players with the aim to maximise player availability, health and athletic performance. This role is required to provide physiotherapy provision all year round and is required to provide professional physiotherapy support for training and matches.

Physiotherapy Services Management	 Manage and develop the Physiotherapy service provision, delivery and facilities for the Men's Senior teams, while providing oversight on Academy and Performance Pathway programmes (in accordance with the England and Wales Cricket Board's (ECB) County Partnerships Agreement) Coordinate on the assessment, diagnosis and management of player injury and illness, and engage the Chief Medical Officer (CMO) appropriately. In collaboration with the CMO and HoSM, ensure strong governance and processes underpin the department, including a clear wellbeing pathway and medical screening. 				

Physiotherapy Support	 To work in collaboration with the Head of Science and Medicine, Chief Medical Officer and other YCCC Physiotherapists to provide a high quality physiotherapy service to support the Men's Senior Teams and help to support the Academy where required. Skilled diagnostic assessment, treatment and design of suitable intervention to manage player injuries and maximise training and match availability. To provide match and training trauma cover primarily for Senior Men's Squads but occasionally across the Club. Be able to operate remotely to ensure continuity of high level support while players are overseas. Liaise with international team stakeholders, where required. To participate in, lead and champion YCCC and ECB led clinical, performance and research projects.
Reporting and Stakeholder Relations	 Communicate non-confidential headline availability and fitness status information with the coaching staff. Engage with the multi-disciplinary team and coaching staff to set bespoke physical preparation programmes for performance and maximum availability for each player. Liaise with the ECB's S&M team regarding support and management for centrally contracted England players, as well as potential England international squad and pathway programme players. Ensure medical record-keeping standards are maintained at a satisfactory level as per industry standards and are entered on to the ECB's Athlete Monitoring System ('Smartabase').
Innovation and Continuous Improvement	 Undertake appropriate professional development to keep abreast of world's best practice and current evidence-based research in cricket. Contribute to the department's in-house professional development programme.
